
Our campus in Geelong is located in the heart of the city with easy access to train, buses, car parks and eating facilities readily available. It is an easy 5-minute walk from train station.

- Each student will be asked to provide a Statement of Attainment for units completed. Veritas Education will determine credit transfers on a case by case basis and will create a training timetable specific to each student to accommodate units already completed.
